

TERMS AND CONDITIONS:
PRIDE OF SCOTLAND PRIZE DRAW

(Prize Draw)

1. The promoter is Carnival plc trading as P&O Cruises Carnival House, 100 Harbour Parade, Southampton SO15 1ST (**Promoter**).
2. The terms and conditions which apply to this Prize Draw are available at pocruises.com/pride-of-scotland-prize-draw. By entering this Prize Draw, you will be deemed to have read and understood these terms and conditions and to have agreed to be bound by the same.

How to Enter

3. The Prize Draw will run from 12:00 BST on 14 April 2026 (**Opening Date**) until 23:59 BST on 24 April (**Closing Date**) inclusive.
4. To take part in this Prize Draw you must visit: www.pocruises.com/pride-of-scotland-prize-draw after the Opening Date and complete and submit the entry form available there.
5. All entries must be received by the Promoter no later than 23:59 BST on the Closing Date. All entries received after the Closing Date are automatically disqualified.
6. Only one entry to the Prize Draw is permitted per person. If you enter the Prize Draw more than once, any entries you have submitted will be disqualified.
7. No purchase is necessary to enter the Prize Draw.

The Prize

8. One (1) prize is available and one (1) winner ("**Winner**") will be selected.
9. The prize consists of two (2) tickets to the 2026 Pride of Scotland Awards with P&O Cruises on 8 June 2026 at the Hilton Glasgow including red carpet arrival, dinner, the awards presentation and attendance at an after awards celebration event with P&O Cruises ("**Prize**").
10. The Prize is non-transferrable, non-exchangeable and no cash alternative is available.

Winners

11. Winner will be randomly selected from all valid entries received by the Promoter before the Closing Date.
12. Winners will be required to show proof of age (Driver's Licence or Passport) before they receive any alcohol.
13. The Winner will be contacted by email, so please take extra care to give your correct email address when you enter the Prize Draw.
14. The Winner of the Prize will be notified by the Promoter as soon as possible following the Closing Date of the Prize Draw. Winner must follow all instructions provided to them by the Promoter to redeem their Prize.
15. Should the Promoter be unable to contact the Winner within 14 (fourteen) days of the Closing Date or should the Winner be unable to accept the Prize, the Promoter reserves the right to award the Prize to an alternative winner drawn in accordance with these terms and conditions.
16. If such alternative winner does not respond in 14 (fourteen) days or is unable to attend the Prize event, the Prize will be forfeit and the Promoter reserves the right not to award the Prize.

Eligibility

17. The Prize Draw is open only to UK residents aged 18 (eighteen) or over except the following persons:

- a. Employees of the Promoter (or any of their associated or group companies),
 - b. Employees or agents of any suppliers to the Promoter, or

Limitation of Liability

Otherwise, the exclusions described at clauses 20 and 21 will apply. References to the "Promoter" in these paragraphs include all of the Promoter's associated companies, agents or any other third parties involved in the Prize Draw.
20. The Promoter will not be responsible for (and will have no liability in connection with) the following occurrences, to the extent that they occur for reasons beyond the Promoter's reasonable control:
- a. any postponement or cancellation of the Prize Draw,

 - c. any act or default of any third-party supplier.
21. The Promoter does not accept responsibility for network, computer, hardware or software failure of any kind, which may affect the sending, receipt or processing of your entry.

Personal Data
