

TERMS AND CONDITIONS:

1. The promoter is Carnival plc trading as P&O Cruises, Carnival House, 100 Harbour Parade, Southampton SO15 1ST (**Promoter**).
2. The terms and conditions which apply to this Prize Draw are available at: www.pocruises.com/win-a-cruise. By entering this Prize Draw, you will be deemed to have read and understood these terms and conditions and to have agreed to be bound by the same.

How to Enter

3. The Prize Draw will run from 9.00am on Monday 1 July 2024 (**Opening Date**) until 11.59pm on Thursday 25 July 2024 (**Closing Date**) inclusive.
4. To take part in this Prize Draw you must visit: pocruises.com/win-a-cruise after the Opening Date and complete and submit the entry form available there.
5. All entries must be received by the Promoter no later than 11.59pm on the Closing Date. All entries received after the Closing Date are automatically disqualified.
6. Only one entry to the Prize Draw is permitted per person. If you enter the Prize Draw more than once, any entries you have submitted will be disqualified.
7. No purchase is necessary to enter the draw.

The Prize

8. One prize is available. The prize is a cruise for two adults (aged 18 and above) sharing a 'GF grade' Balcony cabin on board the Promoter's ship Arvia during cruise number K425 which departs from Barbados on 22 November 2024 and lasts for 14 nights (the **Prize**).
9. The Prize includes accommodation on board, on-board main meals (excluding specialty restaurants for which an additional charge will apply), on-board entertainment and use of most facilities on board.
10. The Prize does not include transportation to and from the winner and/or their guest's homes to the departure airport, travel insurance, drinks, spa treatments, shore excursions, luggage fees, personal expenses, or purchases made on board.
11. The Prize will include economy-class return flights from and to selected UK Airports and transfers between the destination airport and the ship. The Promoter reserves the right to substitute any flights included within a Prize for alternative flights following a change to a Prize permitted by these terms.

It is the responsibility of the prize winner to ensure they and their guest have valid passports and travel insurance, meet all required travel requirements, and obtain any vaccinations and visas required to take part in the Prize. The winner and their guest are required to have adequate travel insurance as a condition of travel.

Winners

16. One winner will be randomly selected from all valid entries received by the Promoter before the Closing Date.

17. The Promoter will contact the winner as soon as practicable following the Closing Date using the details provided when entering the Prize Draw.
18. Should the Promoter be unable to contact the winner within 10 days of the Closing Date or should the winner be unable to accept the Prize, the Promoter reserves the right to award the Prize to an alternative winner, drawn in accordance with these terms and conditions.
19. By entering the Prize Draw you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your competition entry.

Eligibility

20. The Prize Draw is only open to all UK residents aged 18 or over except the following persons:
 - a. Employees of the Promoter (or any of their associated or group companies),
 - b. Employees or agents of any suppliers to the Promoter, or
 - c. members of the immediate family or households of the persons shown at 19 a) and b) above.
21. No bulk or third-party entries will be accepted. The Promoter will not accept entries that are automatically generated by computer; illegible, have been altered, reconstructed, forged or tampered with or are incomplete.

Limitation of liability

22. There are certain things for which the Promoter does not accept any liability to you. The Promoter cannot exclude or limit its liability for death or personal injury caused by its negligence, or loss caused by a false statement where the statement is made fraudulently. Otherwise, the exclusions described at clause 23 and 24 will apply. References to the "Promoter" in these paragraphs include all of the Promoter's associated companies, agents or any other third parties involved in the Prize Draw.
23. The Promoter will not be responsible for (and will have no liability in connection with) the following occurrences, to the extent that they occur for reasons beyond the Promoter's reasonable control:
 - a. any postponement or cancellation of the Prize Draw,

General

29. These terms and conditions shall be governed by English law, and the parties submit to the non-exclusive jurisdiction of the courts of England and Wales.
