

TERMS AND CONDITIONS:  
P&O CRUISES Win a Cruise PRIZE DRAW

(Prize Draw)

1. The promoter is Carnival plc trading as P&O Cruises, with its registered office at Carnival House, 100 Harbour Parade, Southampton SO15 1ST (**Promoter**).
2. The terms and conditions which apply to this Prize Draw are available at <https://www.pocruises.com/win-a-cruise/competition-terms>. By entering this Prize Draw, you will be deemed to have read and understood these terms and conditions and to have agreed to be bound by the same.

**How to Enter**

3. The Prize Draw will run from 09:00am GMT on 24 October 2025 (**Opening Date**) until 11.59pm GMT on 31 October 2025 (**Closing Date**) inclusive.
4. To take part in this Prize Draw, you must visit: [pocruises.com/win-a-cruise](https://www.pocruises.com/win-a-cruise) after the Opening Date and complete and submit the entry form available there.
5. All entries must be received by the Promoter no later than 11.59pm GMT on the Closing Date. All entries received after the Closing Date are automatically disqualified.
6. Only one entry to the Prize Draw is permitted per person. If you enter the Prize Draw more than once, any entries you have submitted will be disqualified.
7. No purchase is necessary to enter the draw.

**The Prizes**

8. One prize is available. Prize is a one cruise holiday for 2 adults sharing a 'GF grade' Balcony cabin on board the Promoter's ship 'Arvia' travelling on K605 26 February 2026 from Barbados for 14 nights (**Cruise Prize**).

10. Booking of Cruise Prize must be made by winner by 28 November 2025. If Cruise Prize winner fails to book Cruise Prize by this date the Promoter reserves the right to allocate the corresponding Cruise Prize to another winner drawn in accordance with these terms.
11. Cruise Prize includes accommodation on board, on-board main meals (excluding speciality restaurants for which an additional charge will apply), on-board entertainment and use of most facilities on board.
12. Cruise Prize does not include transportation to and from the winner and/or their guest's homes to airport, travel insurance, drinks, spa treatments, shore excursions, luggage fees, personal expenses, or purchases made on board.
13. The Cruise Prize will include economy-class return flights from and to selected UK Airport and transfers between the destination airport and the ship. The Promoter reserves the right to substitute any flights included within a Cruise Prize for alternative flights following a change to a Cruise Prize permitted by these terms.
14. It is the responsibility of Cruise Prize winner to ensure they and their guest have valid passports and travel insurance, meet all required travel requirements, and obtain any vaccinations and visas required to take part in the Cruise Prize. Cruise Prize winner and their guest are required to have adequate travel insurance as a condition of travel.

Prize, such alternative prize may take place on board a different vessel or during different dates if commercial considerations or other events outside the Promoter's control require, such circumstances and events including but not limited to the cancellation or restriction of any Prize in accordance with any government-issued guidelines.

### **Winners**

18. The Promoter will contact the winner by email as soon as practicable following the Closing Date using the details provided when entering the Prize Draw.
19. Should the Promoter be unable to contact the winner within 21 days of the Closing Date or should the winner be unable to accept any prize, the Promoter reserves the right to award the Cruise Prize to an alternative winner, drawn in accordance with these terms and conditions.
20. By entering the Prize Draw you agree to the collection, retention, usage and distribution of your personal information in order to process and contact you about your competition entry.

### **Limitation of liability**

24. There are certain things for which the Promoter does not accept any liability to you. The Promoter cannot exclude or limit its liability for death or personal injury caused by its negligence, or loss caused by a false statement where the statement is made fraudulently. Otherwise, the exclusions described at clause 25 and 26 will apply. References to the "Promoter" in these paragraphs include all of the Promoter's associated companies, agents or any other third parties involved in the Prize Draw.
25. The Promoter will not be responsible for (and will have no liability in connection with) the following occurrences, to the extent that they occur for reasons beyond the Promoter's reasonable control:
  - a. any postponement or cancellation of the Prize Draw,

  - c. any act or default of any third-party supplier.
